Promotion and Claim Period	Promotion and Claim Period commences on: 12.01am AEST on 18 July 2019 Promotion and Claim Period concludes on: 11.59pm AEST on 31 October 2019
Eligible Claimants	<p>The promotion is only open to families who enrol at least one child with the Centre for a minimum of three days per week, excluding management and employees of the Promoter and direct family members of the management and employees of the Promoter.</p> <p>The Promoter is responsible for determining whether a person is an Eligible Claimant in its absolute discretion.</p>
How to Participate	<p>To participate in the Promotion and claim the Rebate, an Eligible Claimant must:</p> <ol style="list-style-type: none"> (a) During the Promotion and Claim Period, enrol at least one child at the Centre (b) Complete all enrolment forms and have this handed to a Centre Manager; (c) Pay all fees required to pay to confirm the child’s enrolment with the Centre.
Rebate	<p>The Rebate is equivalent to four weeks of the payment component of the Eligible Claimant’s fees. The Rebate will automatically be credited to the payment component of the Eligible Claimant’s fees.</p> <p>The Rebate will be paid to the Eligible Claimant in four equal annual instalments from the enrolment date based on the number of days enrolled and is only valid for one child of the Eligible Claimant. If the referee reduces the number of days enrolled during the Rebate period then the Rebate will be adjusted and based on the current days per week of the Referee. If the referee leaves the Centre before the Rebate is paid, this offer becomes null and void.</p>
Other terms and conditions	<ol style="list-style-type: none"> 1. The details above and the following clauses collectively form the terms and conditions of this Promotion and each claimant is responsible for ensuring his or her familiarity with these terms and conditions at the time of participation. Participation in the Promotion is deemed acceptance of these terms and conditions. 2. The Rebate is limited to one child per family. 3. The Rebate will only be paid provided the Eligible Claimant’s fees are up to date and are not in arrears.

4. The Promoter's decision in relation to any aspect of these terms and conditions and the Promotion is final and binding on every person who participates. No correspondence will be entered into.
5. Claimants can only participate in the Promotion in their own name and those using multiple aliases will be disqualified.
6. Incomplete, indecipherable, incorrect or illegible referral forms will be deemed invalid. Claimants are responsible for ensuring their correct personal details are provided and any updated details are notified to the Promoter. The Promoter accepts no responsibility should an Eligible Claimant fail to receive their Rebate because of a failure to notify the Promoter of correct details.
7. The Promoter may, in its sole discretion, declare any claim or claimant invalid if the claimant
 - (a) Disrupts, annoys, abuses, threatens, harasses, or attempts to do any of these things to the Promoter;
 - (b) Submits a claim that is not in accordance with these terms and conditions;
 - (c) Engages in conduct in relation to this Promotion which is misleading deceptive fraudulent or damaging to the Promoter's goodwill or reputation.
8. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law to modify, suspend, terminate or cancel the Promotion, as appropriate, subject to any directions from any relevant authority.
9. As a condition of claiming the Rebate, the claimant may be required to sign any legal documentation as and in the form required by the Promoter and/or Gift supplier.
10. Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence) for any personal injury, or any loss or damage (including loss of opportunity) whether direct, indirect, special or consequential, arising in any way out of the Promotion including but not limited to, where arising out of the following:
 - (a) Any technical difficulties or equipment malfunction (whether or not under the Promoter's control)
